Service request guidelines

All service requests are made through the VCJPA Risk Control Manager. All efforts will be made to accommodate requests based on staff availability.

Members may contact the VCJPA Risk Control Manager throughout the year to schedule services or may set their desired training timeframe at the beginning of the program year. VCJPA will send out periodic reminders to members and their risk control contacts to remind them to schedule services. Risk Control Staff will contact members prior to the scheduled service date to confirm and finalize the service details.

Risk Assessment and Action Plan	1 to 2-days of on-site time; some services can be provided virtually	Conduct a focused risk management assessment for a member, including discussion of member's loss history, action plan development, and review of the available risk control resources. Services also include on-site inspections, interviews with staff, and report writing.
On-Site Inspections	Depending on the site or facility will depend on the duration. Typically, a few hours and	On-Site inspections of facilities or corporate yards will focus on offices, storage rooms, bathrooms, building exteriors, kitchen/break rooms, interior work areas, machine shops equipment storage material storage, chemical storage etc.

<p>Occurrence (Accident/Incident) Investigation Training</p>	<p>done in person</p> <p>1-hour training session Can be provided virtually</p>	<p>This training focuses on the occurrence management process and includes occurrence investigation techniques to find multiple causal factors, develop appropriate corrective actions, and follow-up to ensure corrective action implementation. This training is designed for management and supervisor staff. This is a 1-hour training session that can be provided in-person or virtually.</p>
<p>Driving Safety: Making Better Driving Decisions and Reducing Complacency Training</p>	<p>2-hour training session Can be provided virtually</p>	<p>This training will include a focus on loss cause drivers for the JPA, as well as good defensive driving techniques. This program includes discussion, lecture, and video formats and is designed for drivers. This is a 2-hour training session and can be provided in-person or virtually.</p>
<p>Ergonomic Evaluations and Training Safe Lifting Musculoskeletal Sprains/Strains</p>	<p>1 hour evaluation per workstation Can be provided virtually or on-site</p>	<p>Ergonomic evaluations can be conducted for office and industrial positions. This may include on-site or virtual evaluation, employee coaching, and report development. Ergonomic training sessions are available</p>
<p>Slips, Trips, and Falls Training Hiking Best Practices</p>	<p>2-hour training session Can be provided virtually</p>	<p>This training will include a focus on the tools and information to identify and correct conditions and work practices that could result in same level falls. In addition, we will discuss proper selection and design of floor surfaces, common risk factors (people, footwear, flooring, and obstacles), floor testing, and fall investigation. This is a 2-hour training session and can be provided in-person or virtually.</p>
<p>Policy/Program Development</p>	<p>2-day consultative service Can be provided on-site or virtually</p>	<p>Risk Control staff will provide guidance in the customization of policy templates or the revision of existing written safety program documents to meet the agency's needs.</p>
